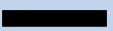

GUIDE TO CRIMINAL ACTIVITY PREVENTION AND RESPONSE

MISSING PERSONS OR CRIMINAL ACTIVITY

You should immediately dial the yacht's emergency number, 911, to report any missing person or criminal activity. The yacht's Security Department is responsible for responding to all alleged crimes and missing persons and can be contacted directly at any time by dialing 3620 or "0" for the Operator.

The Medical Center on Deck 9 can be contacted at any time also by dialing 300 or "0" for the Operator for any required medical assistance.

The Ritz-Carlton Yacht Collection has zero tolerance for crime on board its yacht. On international voyages that embark or disembark in the United States, The Ritz-Carlton Yacht Collection is required by federal law to report onboard felonies and missing U.S. nationals to federal agencies.

For a missing U.S. national and all serious felonies (homicide, suspicious death, kidnapping, assault with serious bodily injury, sexual assaults as defined by federal laws, firing or tampering with the yacht, or theft of money or property in excess of \$10,000), the incident must be reported to the F.B.I. by telephone as soon as possible, and to the U.S. Department of Homeland Security electronically. These requirements apply to incidents that occur on board in U.S. territorial waters, or on the high seas or in foreign waters if the assailant or victim is a U.S. national.

The F.B.I. can assert criminal jurisdiction in all of these circumstances. Each of the nations visited, as well as the yacht's nation of registry, may also assert jurisdiction and / or impose additional reporting requirements. The Ritz-Carlton Yacht Collection reserves the right to report any / all criminal allegations to any national, state or local law enforcement agency in addition to those mentioned.

For missing persons or felonies arising at any time during the voyage, you are strongly encouraged to contact the yacht's Security Department immediately. You may also independently contact the F.B.I. or U.S. Coast Guard, and for incidents within state or foreign waters or ports you may, in addition, contact local law enforcement authorities. Contact information for these entities and the National Sexual Assault Hotline 1- 800-656-4673 as well as other third-party victim advocacy services are listed on the following page, along with the locations of U.S. Embassies and Consulates in the ports visited. Involving the yacht's Security Department early on can help to ensure any alleged crime scene or evidence is preserved for law enforcement officials.

Contact information for these entities in the area of the current cruise will be made available to each guest upon boarding a The Ritz-Carlton Yacht Collection yacht.
