GROUP BENEFITS	FIT GROUPS

BOOKING REQUIREMENTS	Minimum of 12 suites and maximum of 30 suites booked. Suites will be booked and confirmed with deposit and all guest names.
TERMS	The group agreement secures the rate for 90 days with no liability placed on the agency or guest. Guests must also accept Cruise Ticket contract terms.
LOCK-IN RATE	Lock-in rates are valid for 90 days from the date the group agreement is signed. Suites are not held until amount has been deposited.
DEPOSIT REQUIREMENTS	25% deposit required per suite.
PAYMENT SCHEDULE	No additional payments on cruise fare required until 120 days prior to embarkation. Pre and post hotel, air transfers and Marquee events must be paid at the time of booking.
PAYMENT TYPES ACCEPTED	Credit card, wire or ACH.
CANCELLATION POLICY	Cancellations can be made up to 120 days prior to embarkation. Subject to \$250.00 administration fee upon cancellation. Fee is eligible to be used towards a future booking up to year from the booking date.
COMMISSION	In accordance to the agency's Trade Commission Policy earnings tier at the time of booking. Commission does not apply to the Tour Conductor earnings.
ONBOARD GROUP AMENITIES	\$200.00 OBC per suite.
TOUR CONDUCTORS (TC)	One complimentary Terrace Suite per every 12 suites paid. A maximum of two complimentary suites may be earned.
